## **FOOTNOTES TO TABLES**

- (a) Unless otherwise noted, all fees and costs are for two semesters (8 months) or 30 credits.
- (b) The data have not been adjusted to reflect a regular academic year of 8 months because of the different nature of graduate studies, which also includes a research component (program basis may be 12 months).
- (c) Pre-Agriculture/Pre-Architecture/Pre-Dentistry/Pre-Engineering/Pre-Law/Pre-Medicine.
- (d) Special fees are charged for internship students.
- (e) The institution provided an estimated figure.
- (f) This institution offers a veterinary medicine program (DMV). Fees are generally higher for this program than fees charged for other science programs.
- (g) For the first year, then a lesser fee is charged for each subsequent year of the program.
- (h) Additional fees are charged for specific courses which may vary with the faculty offering the course, for course materials or for student societies that are specific to a particular faculty.
- (i) The University of Winnipeg offers graduate programs jointly with the University of Manitoba, the latter handles registration and fees.
- (j) The Technical University of Nova Scotia amalgamated with Dalhousie University in 1998. Dalhousie will handle registration and fees.
- (j) Special fees are charged for co-op students on work terms for which credit hours are granted.
- (j) Beginning in 1997-98, the universities of Quebec have adopted a new fee structure for Canadian students. Fees are lower for residents of Quebec than they are for out-of-province students.
- (j) Tuition for the MBA and/or Executive MBA program are much higher than those charged for most graduate programs.
- (n) Students enrolled in this program may register for more than 30 credits per academic year.
- (o) Data have been adjusted to reflect 30 credits. Students may actually take between 12 and 20 credits per semester.
- (p) Lower fees are charged to Canadian students who were new in 1996-97.
- (q) Normal program length varies depending on the year of study, but fee per credit charge remains the same. Fee indicated is for two semesters (eight months).
- (r) Beginning with 1997-98, specific fees have been established for particular graduate programs.
- (s) This institution offers an optometry program. Fees are generally higher for this program than fees charged for other science programs.
- (t) For the first two years of the program. A lesser fee is charged for each subsequent year.
- (u) As of 1996-97, tuition includes a base fee plus a program fee.
- (v) Data have been adjusted to reflect 30 credits with the exceptions of law, dentistry and medicine

- which have set fees based on an 8 month academic year.
- (w) Data are based on a 30 credit, eight month academic year except for the law program, which is based on an eight month academic year of 29 to 32 credits depending on the year of study.
- (x) This institution offers programs in nursing, pharmacy, rehabilitation medicine and physical education. The tuition for these programs was the same as for the science program.
- (y) Tuition fees for graduate programs vary a great deal depending on the course registration. The figure provided is for 18 units of course weight per year.
- (y) Royal Roads University offers programs which require undergraduate students to compress the last two years of their degree into one full (12 month) year, and graduate students to stay on campus only 5 weeks out of the year.
- (aa) Under a special pilot program, undertaken by an agreement between the Government of Newfoundland and the governments of Malaysia and the United States, 20 foreign students will pay \$30,000 per year.
- (ab) As a result of agreements between the Government of Quebec and other countries such as France, citizens of these countries may be exempted from paying the usual foreign tuition fees, paying instead the same fee as students from Quebec.
- (ac) The lower foreign student fee was introduced to assist some graduate students whose exemption from foreign fees has been removed.
- (ad) The differential fee paid by international graduate students is rebated by the university.
- (ae) No foreign students are accepted for the program.
- (af) A special fee is charged to foreign students.
- (ag) The upper limit of the health service fee is a family rate.
- (ah) Health services included in athletics.
- (ai) Students may opt out of the health care plan.
- (aj) Athletic and health service fees are included in tuition fees.
- (ak) Coop students pay higher health insurance fees.
- (al) Accommodation costs are for university-operated residences and housing. Not included are: accommodations in off-campus private quarters; transportation; and personal expenditures for books, clothing, entertainment, etc.
- (am) Room only option.
- (an) Married student accommodation is geared to income and size of family.
- (ao) Students can increase the board plan to any level, allowing for greater flexibility.
- (ap) Includes mandatory residence association fee.
