SEQUENCE NUMBER

Description

This variable is a unique five-digit number which identifies each individual on the file. Each individual has been assigned a unique sequence number less than 99000 except for Special individuals have been numbered in the 99000's range.

PERIOD OF WARTIME SERVICE

Description

This variable identifies individuals who, as members of the Canadian or Allied Forces, served during World War 1 or World War 2 or the Korean Conflict. Wartime service is not restricted to those who were involved in active combat.

Please note that if the individual served in more than one war, the lowest code was entered. If for example, the individual served in World War 2 and in the Korean Conflict code "1" (World War 1 or World War 2) should be entered.

WARTIME SERVICE: CANADIAN OR ALLIED FORCES

Description

This variable indicates whether the Wartime Service was with the Canadian or Allied Forces. "Allied Forces" applies to any forces that were in alliance with the Canadian Forces during World War 1 or World War 2 or the Korean Conflict.

- (i) Canada's World War 1 allies included the British Empire, the United States, France, Russia, Japan, Italy.
- (ii) Canada's allies in World War 2 included the United Kingdom, the United States, France, the U.S.S.R..

WARTIME SERVICE: SERVICE OVERSEAS

Description

For individuals with Wartime Service, this variable indicates whether or not it was served outside the territorial waters of Canada. The key point here is that "Overseas" is in relationship to Canada.

Please note that for this survey we consider Newfoundland to have been part of Canada prior to 1949.

Civilian Service also includes the Red Cross, St-John Ambulance Corps, RCMP, Salvation Army, civilian instructors in Service Schools or establishments and civilians attached to reserve units of the military.
